Hart Hodges, (he/him/his) Co-Director, Center for Economic & Business Research, WWU



Hart Hodges, PhD joined the faculty at Western Washington University in the Fall of 2000 and serves as co-director of the Center for Economic and Business Research. His research interests include natural resource and environmental economics, health economics, and applied business economics.
