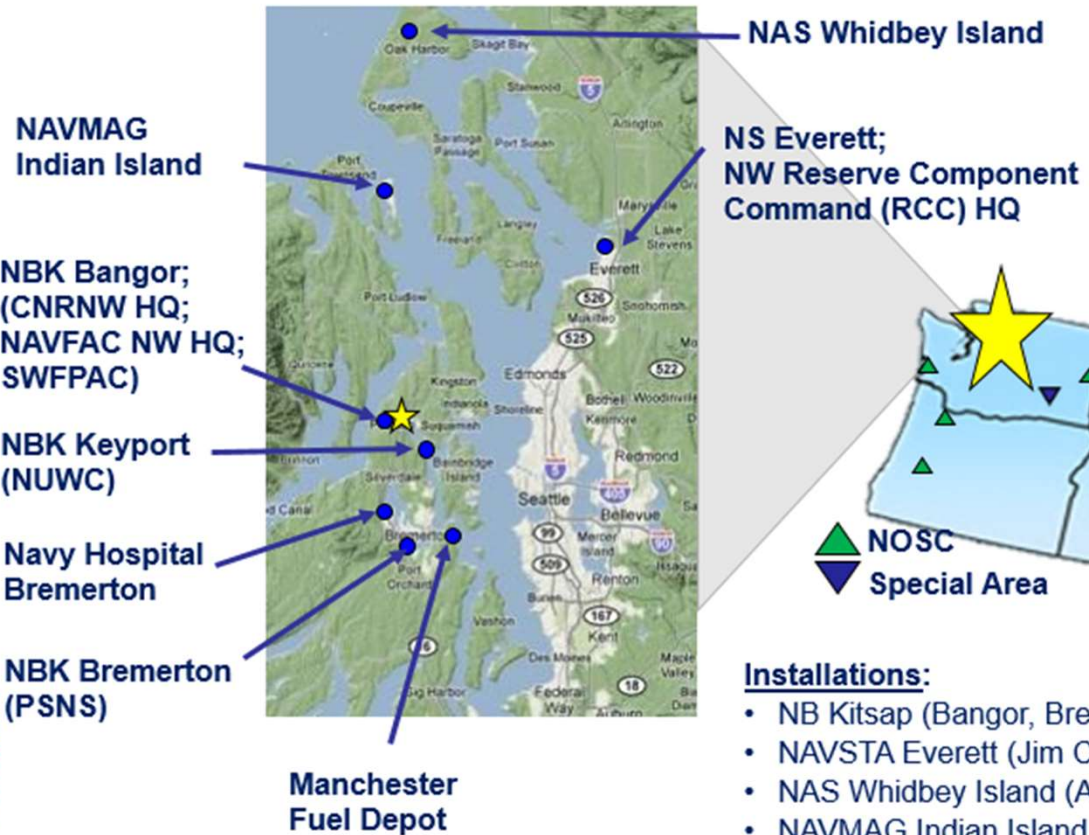

P454 MULTI-MISSION DRY DOCK

PURPOSE

- *Construct a new, multi-mission dry dock to support CVN-78 Class nuclear aircraft carriers and all Fleet nuclear submarine classes*
- *Address critical dry dock capability, capacity, and seismic survivability at Puget Sound Naval Shipyard*

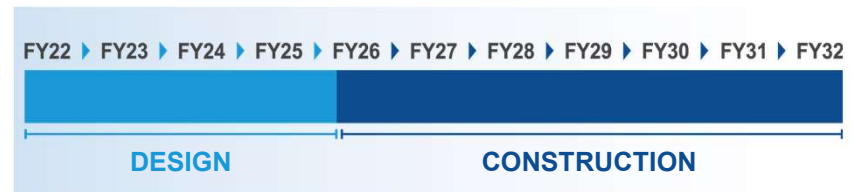


PRE-AWARD

POST-AWARD

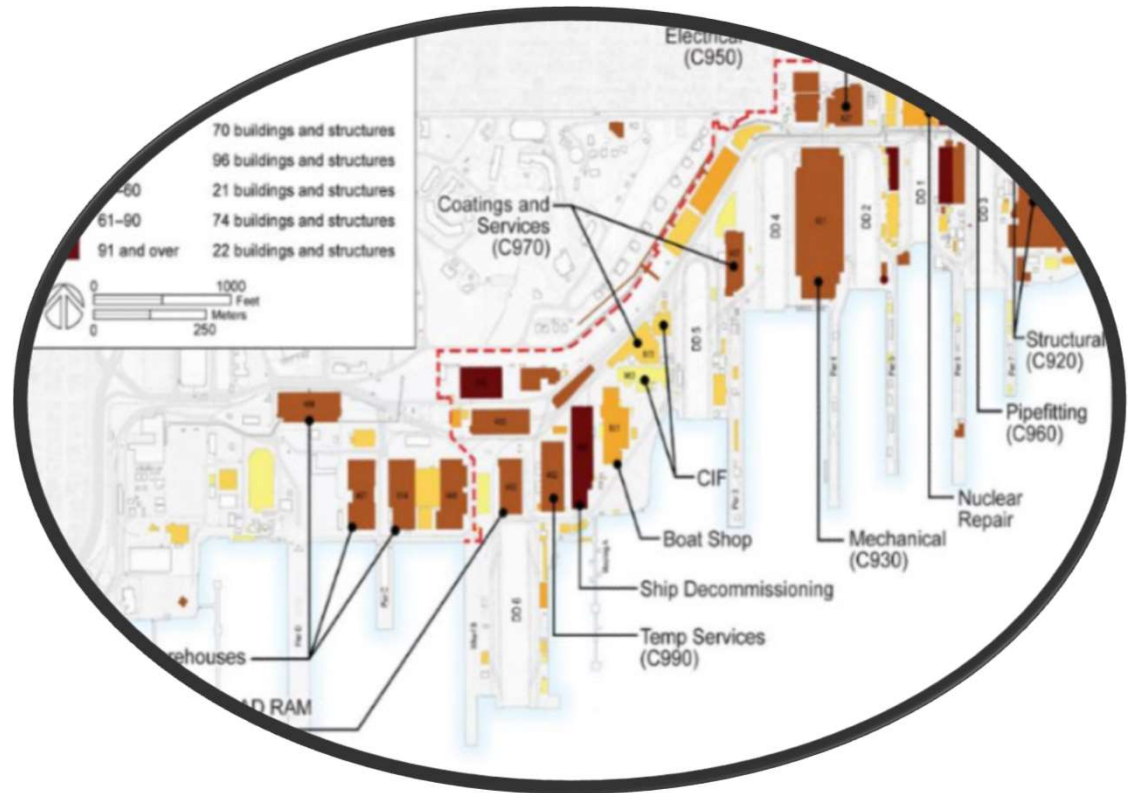
- *Manage all aspects of post-award administration*
