#### 2022 Kitsap County Top Employers List

The Center for Economic and Business Research at Western Washington University and the Kitsap Economic Development Alliance ask businesses for the number of workers they employ in Kitsap County each year – the following table is for employment counts requested as of 12/31/22. While it may seem straightforward, labor information can get complicated due to differences in definitions, how to count people who work in different locations during the year, and other potential data errors.

This year, the Top Employers list for Kitsap returned to its original form of data collection: surveying. While the list is slightly shorter, employee counts are "primary data" or actual recorded counts from local businesses, rather than secondary data from large, aggregated data sources. This should provide a more accurate count of local employment than the previous combined datasets. Numbers in the table should be used for discussion purposes and reference, with an understanding of the uncertainty surrounding volunteered data and self-selection bias of responses. Survey response rates have also been lower post covid-19 which can contribute to volatility of data due to sample size.

Key Insights:

- Of our top 10 employers, 7 are public
- The top 50 employers are split almost evenly between public and private entities
- Over half of the Top Employers have increased their workforce
- School districts have added the most employment in 2022
